Faculty members/Scholars selected for awards will be facilitated/ awarded with an appreciation letter and memento.

B. SEED MONEY FOR RESEARCH PROJECTS

BPSMV, since its inception in 2006, has been continuously striving to promote Research in the University by providing seed money to its faculty members. Faculty members in the University are inspired to carry our theory research on women, socially relevant, and Community based Research. The University provides seed money in various women-centric areas like Women Empowerment, Socioeconomic issues, educational challenges and

highlights, career, technology and entrepreneurship, gender budgeting, human development index, and evaluation of various social welfare schemes. The Guidelines for granting Seed money for the research project are as follows:

- a) The maximum amount of the seed money will be up to Rs. 1, 00000/- (One Lakh\s only);
- b) Duration of Research Project shall be two years;
- c) The faculty members receiving seed money shall have to publish at least two Research Papers in UGC Care Journals;
- d) Project leaders must submit the utilization certificate within two years from the Grant of Minor Research Project date.
- e) The research project proposal should be in PDF format (Times New Roman, 1.5 line spacing with 2-inch margins on all sides), APA referencing style.
- f) The Directorate of Research will screen the projects and ascertain whether these are as per the guidelines or not.
- g) After screening, one committee (including one outside expert) will assess the proposal where the project leader is required to make a presentation and defend their areas.

C. TRAVEL GRANTS

The Faculty member of BPSMV has the opportunity of presenting their papers/seminal works in national and international seminars across the globe in the form of travel grants.

- ✓ The confirmed teachers of the University Teaching Departments and its maintained colleges may be allowed to attend seminars/conferences/workshops. They shall be paid TA/DA and delegation (registration) fee as per university rules if the same has not been allowed by the hosting Institution/Organization.
- ✓, The teachers whose papers have been accepted for deliberations in the conference or who are the office bearers of Organizations / Societies /Associations which organizes conference /seminars/workshop may be treated on duty leave.
- ✓ Such permission for attending the conference/seminar/workshop may be granted subject to the availability of funds, and the application for the grant must reach the office fifteen days before the date of journey and 30 days in case of an international seminar, duly recommended by the Chairperson/Principal of the Department / College.
- ✓ A teacher who has availed of this facility may be considered again only after the expiry of 3 years in case of foreign seminars and conferences. However, special permission may be granted to the aspiring teacher if his/her paper is accepted in the event organized by the top 200 universities of the world in the reference year based on QS World University Rankings / The Times Higher Education World University Rankings.
- ✓ In the case of the National/ International Conference/Seminar in India, the case shall be considered again after one year. However, the teacher may allow at any number of times if his/her paper is accepted in the event organized by the top 100 universities in India NIRF Rankings.

D. UNIVERSITY RESEARCH SCHOLARSHIPS

University Research Scholarship (URS) may be awarded in each University Teaching Department where research facilities are available. The scholarship amount shall be Rs. 9,000/- per month for the first two years, and beyond it, it will be Rs. 10,000/- per month. URS shall be tenable for two years in the first instance, which may be extendable for two years subject to the satisfactory work progress reports of the scholar. An annual contingency grant of Rs.5,000/- shall be admissible to the scholar for stationery, TA/DA and miscellaneous expenses. A one-time grant of Rs. 10,000/- for purchasing books shall be admissible to the Research Scholar.

E. UNIVERSITY PATENT POLICY

The BPSMV is very keen to enhance the number of Patents published/awarded for the last few years and to promote the development and registration of the patent. Patent attorneys/consultants are to be empanelled to guide and help the students and faculty members of the BPSMV in patentability assessment of the research work and the application process while applying for patents/copyright claims.

F. WORKSHOPS/SEMINARS

The BPSMV consistently provide incentives to its various departments/institutes to organize conferences/ workshops/symposiums on the themes related to Research methodology, Intellectual Property Rights (IPR), entrepreneurship, and skill development. Similarly, the Departments/Institutes have been granted permission to organize academic events in collaboration with national and international academic institutions to enhance international exposure. The University inspires various departments to avail external funding options besides financing some of these events.
