1. Definations:

- 1.1 Programme stands for C.C.K.T.
- 1.2 Course stands for individual paper

2. Duration:

- 2.1 The duration of the course is six months including examination and assessment.
- 2.2 Minimum 50 classes for theory and practical will be conducted in 6 months training programme.

3. Admission:

3.1 Eligibility:- The minimum qualification for admission to C.C.K.T. course shall be B.A.M.S. degree including one year rotatory internship training from a recognised Institute.

3.2 Mode of selection:- Merit list will be prepared as per marks obtained in BAMS examination. In case of same percentage, the marks obtained in Shalya Tantra will be seen.

4. Fees:

The programme fee shall be paid by the candidates as prescribed by university from time to time.

5- Teaching methodology:

For theory:- The methodology shall include class room teaching & project work.

For Practical:- I.P.D. & O.P.D. duty & O.T. work in the departments included viva-voce.

6- Examination and Evaluation:

6.1 Final examination will consist of one theory paper and one practical cum viva voce examination of 100 marks each.

6.2 Theory paper is to be set by the course coordinator and practical cum viva voce examination shall be conducted by coordinator in presence of teachers of the department. The medium of instruction and examination shall be English.

6.3: A candidate who fails in the exams has to reappear within one month of declaration of result.

6.4: Candidate has to separately secure 50% marks in theory and practical examination.

6.5: Every successful candidate shall be granted a certificate & detailed mark sheet.
