Statement of the case:-

Department of Basic and Applied Sciences was established in the year 2019. The M.Sc. Physics and M.Sc. Chemistry programme was started with an intake of 30 from the Academic Session 2019-20.

In the current academic session 2022-23 against the intake of 30, the department has received 99 applications in M.Sc. Chemistry and 67 applications in M.Sc. Physics. A request from the In-charge department of Basic and Applied Sciences has been received to increase the 10% seats as there is no extra financial liability on the exchequer of the university.

Therefore, the matter with regard to increase 10% seats over and above the sanctioned intake of M.Sc. Physics and M.Sc. Chemistry programme was submitted to Vice- Chancellor, the same has been approved by her in anticipation of approval of the Academic Council keeping in view of the academic interest of rural girls students. Further, she has desired that the same be placed before Academic Council for approval.

4. To note the action taken by the Vice Chancellor to increase the sanctioned intake of M.Sc. Geography programme from 30 to 40 in the Department of Geography, BPSMV, Khanpur Kalan in anticipation of approval of the Academic Council.

Statement of the case:-

(

Department of Geography was established in the year 2019. The M.Sc. Geography programme was started with the intake 30 seats from the Academic Session 2019-20.

In the current session 2022-23 against the intake of 30, the department has received 199 applications. A request from the Chairperson department of Geography was received to increase the intake from 30 to 40 as there is no extra financial liability on the exchequer of the university.

Therefore, the matter with regard to increase the sanctioned intake of M.Sc. Geography programme from 30 to 40 was submitted to Vice- Chancellor and the same has been approved by her in anticipation of approval of Academic Council without any financial liability. Further, the Vice-Chancellor has desired that the same be placed before Academic Council for approval.

5. To note the action taken by the Vice Chancellor to increase the sanctioned intake of B.A. course from 160 to 240 at Regional Centre, Kharal in anticipation of approval of the Academic Council.

Statement of the case:-

B.A. course was started at Regional Centre, Kharal from the Academic Session 2014 -15 with an intake of 120. Further, on the request of the villagers of the nearby villages the intake was increased from 120-160 from the Academic session 2021-22

In the current Academic session against the sanctioned intake 297 applications have been received. Now, again the request of the nearby villagers has been received to increase the intake from 160 to 240. As there will be no extra financial liability for this, as the existing faculty was requested to take the classes for increase seats.

Therefore, the matter with regard to increase the sanctioned intake of B.A Course from 160 to 240 was submitted to Vice- Chancellor and the same has been approved by her in anticipation of approval of Academic Council without

any financial liability. Further, she has desired that the same be placed before Academic Council for approval.

- 1. The guidelines for improvement examinations will supersede the rules framed earlier by the individual deptts. of the University.
- 2. For professional courses such as B.A.M.S./ Engineering/ B. Pharmacy/ Laws, the rules of improvement will be applicable as per the rules of regulatory bodies. (Annexure-10, Pages-239)

"The students will be promoted to 5th Semester only if she has completed all her 1st semester papers. The university will take the matter to Academic Council and implement the same w.e.f. the session 2014-15 in the academic interests of the University".

Further resolved that since this condition is basically for three years course where as in the University there are other courses having the durations of four and five years. Accordingly, it was resolved that on the same pattern, the promotion policy for the courses having the duration of four and five years will be as under:-

- (i) For promotion to 7th semester, if completed all papers of 1st and 2nd semesters.
- (ii) For promotion to 9th semester, if completed all papers of 1st, 2nd & 3rd semesters.

There will be no such condition on the courses having the duration of less than three years. The above decision will not be applicable on BAMS Course where CCIM Rules are applicable.

Pharmacy programme duly recommended by the concerned HODs, the above promotion policy was also relaxed by the Academic Council for the Academic Session 2017-18, 2019-20 and 2020-21 respectively.
