The Research Scholar, Ms Sunita, represented to the Vice-Chancellor BPSMV/DSW (14th December 2022) and the case of the scholar was presented to the Vice-Chancellor, who directed to refer the matter for placing it to the forthcoming meeting of the BPSMV academic council.

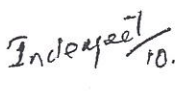
