Bhagat Phool Singh Mahila Vishwavidyalaya is the 'dream come true' of Bhagat Phool Singh Ji, who established a Gurukul for girls at Khanpur Kalan in 1936. The State Government then upgraded the erstwhile Gurukul to the status of a university exclusively for women in August 2006 and named it as Bhagat Phool Singh Mahila Vishwavidyalaya, which happens to be the first State Women University of North India. Since then, BPSMV has undergone a major transformation; 75 years old Gurukul started with only three girls has turned into a modern university with approximately 7000 girls on its rolls studying in various programmes.

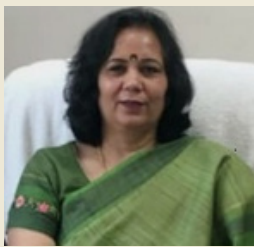

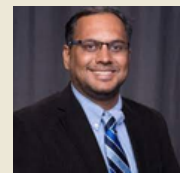

1. Papers should adhere to the following:
 - **Maximum Length:** 5000 words including title/cover page and References
 - **Margins:** One inch on all sides
 - **Font:** Times New Roman, 12 points Justified
 - **Line Spacing:** 1.5
 - **Title Page:** Title, author(s), affiliation(s), contact details, Email addresses
 - **Extended Abstract:** Not more than 500 words and a maximum of five key words
 - **Referencing:** APA style
2. The authors must send a declaration that the paper is original and has not been sent/submitted elsewhere for publication or presentation in any conference/seminar.
3. Selected research papers and case studies after undergoing review procedure will be published in an edited book by a reputed publisher. The publication cost will be paid by the authors.
4. Certificate of presentation will be awarded to registered paper presenters. All authors need to register and submit the application fee as mentioned.
