At the outset, the Vice-Chancellor welcomed all the members, to the 77<sup>th</sup> meeting of the Executive Council. The Vice Chancellor informed the House that Prof. Mahesh Dadhich MSM institute of Ayurveda has been appointed as Chief Executive Officer (Technical), National Medicinal Plant Board (NMPB), Ministry of Ayush, New Delhi on deputation basis. It is a proud moment for the University. The House congratulated Prof. Mahesh Dadhich. Further it was informed that State Government has assigned the responsibility to BPSMV, Khanpur Kalan for mentoring 52 colleges of Sonipat, Panipat, Jind and Kaithal district for preparation of NAAC Accreditation. The Chairperson congratulated the IQAC Cell for their sincere efforts due to which this big responsibility has been assigned to our University. After the exchange of pleasantries, the formal agenda items with the permission of the Chairperson were taken up by the Secretary, Executive Council.

1. Confirmation of the Minutes of 76<sup>th</sup> meeting of Executive Council held on 01/09/2023.

Resolved that the minutes of 76<sup>th</sup> meeting of Executive Council held on 01/09/2023 be confirmed.

2. Follow up Action Report.

Resolved that the action taken report of 76<sup>th</sup> meeting of Executive Council held on 01/09/2023 be noted. Further, the House noted the observations of Dean Academic Affairs on resolution No. 17 w.r.t case of Dr. Nitika, Asstt. Prof. in English, IHL that "she may be allowed to re appear before the Selection Committee after a period of one year from the date of her initial eligibility for promotion in place of one year from the date of meeting of the Selection Committee i.e. 22.08.2023" and the House agreed upon the same.

Further, the Controller of Examinations had submitted his observations on resolution No. 24 i.e. "The Flexi/Special Examination will only be applicable upto extended duration of the course only", the same was noted and approved by the House.
