
Instruction to Candidates


1. This list is provisional, subject to the verification of documents as per the University Prospectus 2025-26

The qualified candidates have to report to the department of Fashion Technology, Teaching Block-II, 3rd Floor (Room No. 317) with original and two set of self-attested copies of following documents: Certificates of 10th, 12th, B.Tech, category, aadhar card, family id latest income certificate, domicile and character certificates, gap year if applicable along with four photographs. (2 set of all documents)
3. Latest EWS/Income certificate/affidavit along with undertaking to the effect that you belong to EWS/SC failing which your admission is liable to be cancelled and the fee will be forfeited without any prior notice.
4. BC category candidates: Latest BC/Income certificate/ affidavit along with undertaking to the effect that you are not covered under the criteria of creamy layer falling which your admission is liable to be cancelled and the fee will be forfeited without any prior notice.
5. The qualified candidates shall deposit the prescribed fee of Rs. 19800/- through online mode up to 17 July, 2025. Please bring ATM/Debit card/ Credit card.






