Date for fee submission for first Merit List is from 14th July, 2025 to 17th July, 2025.
4. Fees submitted after 17th July, 2025 (4:00 P.M.) will not be considered for admission.
5. The qualified candidates who fail to produce required documents and do not submit the prescribed fee will lose the chance of admission and the seat of the particular candidate will be given to next candidate in order of merit.
