# IMPORTANT GUIDELINES/INSTRUCTIONS FOR STUDENTS AND DEPARTMENTS:

- 1. The Chairperson/HOD/Director/Principal/In charges of concerned departments/ regional centers/affiliated colleges & Constituent Institutions are requested to submit the system generated report of aforesaid students within (02) two working days after the last date of form submission as per the above schedule positively, failing which the concerned department will be held responsible for any delay and late receipt of details will not be accepted and allowed to appear for examination.
- 2. In case of late admission / submission of exam forms due to late declaration of results of the same exam for no fault of the candidate(s), no late fee shall be charged within 15 days from the date of declaration of the result(s) of the candidate concerned. Thereafter, late fee will be charged as per above schedule.
- 3. In the event of any last date for submission of forms without or with late fee being holiday(s) declared holiday(s)/the next working day will be deemed to be the last date.
- 4. If the number of teaching days falls short than 180 days (90 days in each semester) in the academic session, it would be the responsibility of concerned teacher to make efforts to cover the loss by taking extra classes. Non- completion of syllabus will not be construed as basis to pre/postpone the exam, once finalized as per date sheet.
- 5. Students have to submit their re-appear exam form in their respective departments/colleges only.
- 6. Examination forms for the session May/June 2025 of all students will not be accepted without ABC IDs.
